

- We now hold regular employee led 'Green Team' meetings to drive stakeholder engagement and find solutions to on site improvements
- Our warehouse has now been converted to sensor driven LED lighting
- We are now using 100% renewable energy for our electricity supply 6 years earlier than planned
- Our waste emissions have been reduced by 5 tCO2e
- Reducing upstream and downstream delivery mileage through improved logistic scheduling
- Diversifying our product portfolio to include more sustainable, locally produced products
- Business travel mileage has been reduced by 16,000 miles by remote & online working
- Introducing employee commuting initiatives and home working policies
- Going paperless across the business
- Exploring more efficient heating sources
- SMART initiatives for the introduction of recycled packaging
- Working with delivery suppliers committed to delivering a net zero service by 2040
- Zero landfill target by 2040
